

Respected Sai brothers, Sairam and good day,

Please refer the below message from AIVP (N) Sri Nimish Pandya and we need to upload **Indian Service Projects** into an International web site <http://sailoveinaction.org> as part of Spreading the Divine Message and by the grace and blessings of our beloved Bhagawan I have been asked to look after this seva.

In this connection I request you all to send initially **One Best Service Project** from your State and in due course of time you can add more projects. All the reports would be suitably scrutinized so as to suite for uploading into the site <http://sailoveinaction.org> which is very unique and covers the services done/being done by Sri Sathya Sai Seva Organisation from all the continents.

### **The Service Project should be**

- 1) A long term service project spanning at least for 6 months or more time.
- 2) A Socially benefitted service (s) particularly for poor and underprivileged
- 3) A medical project-run on a continuous and consistent basis providing Medicare to villagers.
- 4) Any critical care and Follow up cases in sizable number-like mass polio camps, taking care of pregnant women for a continuous period of not less than 6 months or medical help on a long term basis.
- 5) Providing Pure Drinking water (water purification plants) or digging bore wells benefitting the entire village etc.
- 6) Agri projects where farmers get better yield after Sri Sathya Sai Seva Organisation takes up the services and extend help
- 7) Power generation and alternate energy sources made available to villagers by our Organisation.
- 8) Sanitation and housing projects taken by Sri Sathya Sai Seva Organisation.
- 9) Seva Projects involving moral values inculcation and bringing a change in behavior/transformation/character build up (long term EHV classes) and where Sri Sathya Sai Seva Organisation contributed Social & Human values. Examples are required to project them.
- 10) Rural Community Centers where multiple services are extended for a period of one year or more.
- 11) If your services are not falling into these categories, you may still send and they would be studied and if found suitable they will be accepted.

### **Running Matter:**

- 1) Try to give as brief as possible but the project report must be supported by figures/numbers and entire article can be 2-3 pages (A4 size) and both word and PDF formats must be sent. **Only PDF is not accepted.**

- 2) **You may split the write up (article) into**
  - a) Introduction
  - b) Main content
  - c) Impact of the service
  - d) Concluding Remarks
- 3) Appropriate **photos/images** in JPG format must be attached.
- 4) **Start & end** of the project **dates** must be mentioned, if it is running 'say' till date.
- 5) The main person's name who conceptualized and involved in the project physically has to be mentioned and if more than 2 persons have taken lead part, **please give two names only.**
- 6) Write the report in past tense.

Any doubts you get and/or any clarifications required please drop a mail and I will be happy to help you.

Send report through a **common mail ID** and reports from many people will be difficult to assess and so request you to send through State President mail ID or State Archives or any nominated person by the State President. **This will not apply to State Coordinators and National Coordinators but make sure you copy to your State President.**

Looking forward to work with all of you and anticipating an early action and will be much appreciated.
